Certificate and, GST registered number** and on production of proof of having similar experience, including date of completion of work, actual value of work done etc., should be submitted in online.
- c.** Bids must be uploaded with scanned copy of EMD in the prescribed format drawn in favor of SIPCOT Ltd., Chennai.
- d.** The technical documents of Annexure-I & Annexure-II can be read and signed. The same can be scanned as a pdf file which can be uploaded in the first cover.
- e.** The original EMD shall be received by the Superintending Engineer, SIPCOT on or before **07.02.2023, 15.00 Hrs** (by manual) failing which, the bid shall be summarily rejected.

- ii. **Two cover system shall be adopted for the above work.** The tender document shall be filled with relevant details duly signed and the completed tender document along with required certificates should be submitted through online.
- a. The tender will be opened by the Superintending Engineer on the date and time stipulated above. If the last date of receipt of tender happens to be a Public Holiday, the tenders will be received and opened at the above said time on the next working day. The tenderers who are desirous of making field visits may do so at their own cost.
  - b. The technical cover containing EMD and pre-qualification documents as prescribed in the tender documents received through "online" only shall be opened on **07.02.2023 at 15.30 Hrs**(as per server system clock) in the office of the Superintending Engineer, SIPCOT, Chennai.
  - c. The financial cover containing price Bid documents of qualified bidders in the prequalification only will be opened on a later date with due intimation to them.
  - d. Addendum/Corrigendum if any, it will be available only in the above website.
  - e. The contractor should produce the documents for own possession of sufficient plants & machineries and obtain certificate from the Project officer, Sriperumbudur as specified in the tender documents for working of plants & machineries.
